I am directed to refer to this Department's letters No.38020/2/2010-FC.3 dated 11th January, 2011 on the subject mentioned above and to say that consequent upon increase in the Quarterly Price Index average from 176.66(2001-100) of the previous quarter to 180.66 (4 points), the Department of Public Enterprises has further modified the rates of dearness allowance payable to the employees/Executives of the Public Sector Undertakings with effect from 01.01.2011 vide their O.M. No.2(70)/2008-DPE (WC) –GL-I/11 dt.17th January, 2011, (copy enclosed). Therefore, IDA Pensioners/Family Pensioners covered under the instructions contained in this Department's letters No. 38020/1/2009.FC-3 dated 25.10.2010 and 1.11.2010 have now become entitled for payment of Dearness Relief (IDA) at the revised rates w.e.f. 01.01.2011 onwards.

2. Accordingly, approval of the Government is conveyed for the payment of dearness relief to the IDA Pensioners/Family Pensioners of FCI at the following modified rates effective from 01.01.2011 onwards: -
