MINUTES OF THE MEETING HELD ON 7TH JUNE 2018 with HEAD OF CPPC of the Authorized Banks of Pension.

Main Agenda:

To discuss the issues of non submission of E-Scrolls, Pending e-scrolls as per the discrepancy Report, etc.

Description:

At the outset, Chief Controller (Pension) welcomed all the officers of the CPPCs. The meeting was attended by Sr.TD (NIC), ACA, & Sr. AOs/ AAOs of respective sections of CPAO.

The Issues discussed in the meeting were as under:

1. Assistant General Manager, Central Bank of India informed that Bank is using the new portal w.e.f 01-04-2018 and ensured that there will be no of problem in future. It was also informed that the pending scrolls were uploaded by them on 06-06-2018.

2. Chief Manager, Dena Bank informed that there was a problem in the software for uploading the Scrolls. They were advised to take the latest format of e-Scroll.
