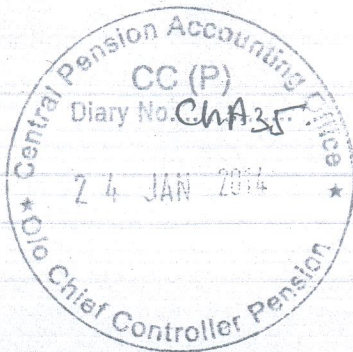



- i) The name(s) of permanently disabled child/children/siblings and/or dependent parents may be added to the PPO issued to the retiring Government servant only if there is no other eligible prior claimant for family pension other than the spouse.
- ii) The authorisation made shall become invalid in case a person becomes member of family after issue/amendment of such PPO and is entitled to family pension prior to the disabled child/sibling/dependent parent at the time of the death of the pensioner/spouse.
