Public Auction Notice

Central Pension Accounting Office on behalf of President of India invites interested auctioneer for public auction for disposal of unserviceable materials on '*as is and where is basis*'. *The items will be auctioned in two lots i.e. lot A and lot B as per list enclosed.*

The auction will be conducted on 18/02/2015 **at 3 p.m. at Central Pension Accounting Office Trikot-II, Bhikaji Cama Place, New Delhi-110066.**

Terms and conditions of the auction

- 1) The auction material list can be inspected and list can also be collected from CPAO office during any working day between 10 a.m. to 4 p.m. upto 17/02/2015.
- 2) All the bidders will have to deposit **Earnest Money Deposit (EMD) of Rs. 5,000/-** in the form of cash before starting of the auction bid. Those who will not deposit the money shall not be allowed to participate in the auction.
- 3) The bidders should satisfy themselves about the material before taking part in the auction.
- 4) The successful bidders will have to deposit 25% of the bid amount immediately and balance amount within two days on acceptance of bid. The EMD will be adjusted in the amount so deposited. If the successful bidder fails to deposit the said amount within stipulated time period, the EMD shall stand as forfeited.
- 5) The EMD of unsuccessful bidders will be refunded immediately as soon as auction is over.
- 6) The material will be collected by the successful bidder on the basis of 'as is and where is' and department will not be responsible for the quality and condition of the material and no claim whatsoever will be entertained by CPAO in this regard.
- 7) The bidder shall be responsible for any kind of loss to Government property during the removal of the auction material from the site and recovery of the same will be made from him.
- 8) As far as possible auction material must be removed by the bidder **within three days** from the date of acceptance of bid. However, material will be allowed to remove only after payment of bid money which will be accepted in cash.
- 9) If material is not removed within three days, **storage charges @200/- per day** will be charged from the bidder.
- 10) The bidder will leave storage place of the material quite clean.
- 11) The material will be removed from the site in the presence of the bidder himself.
- 12) The undersigned reserves the right to reject any bid or to cancel the auction without assigning any reason.
