2. The quotations would be accepted only from those agencies who produce proof of authorisation/approval of Deptt. of Labour, Delhi Admn., NCT, Delhi or who are registered in security services or registered under Company Act.
3. The quotations in the pro forma prescribed by this office only will be accepted. The quotations submitted in any other pro forma will be summarily rejected.
4. The quotation form along-with terms & conditions may be obtained from CPAO on written request till **6th April, 2010 till 4 P.M.** or can be downloaded from the web site of this office **www.cpao.nic.in**.
5. Quotations will be received at CPAO till 3 P.M. on or before **8th April, 2010** and opened at 3:30 P.M. on the same day. The sealed quotations are to be deposited in the 'Tender Box' placed on the Ground Floor.
6. Quotations should be submitted in sealed cover. Open quotation will not be accepted.
7. The contract will be valid for a period of one year. However the Competent Authority may terminate the contract at any time without assigning any reason.
8. The selected party will be required to deposit a security amount of **Rs.10,000/- (Rupees ten thousand only)** by way of DD or Cheque in favour of PAO, CPAO,

- 11 The Agency approved for award of the contract shall be responsible for character and police verification of the Guards deployed on duty.
- 12 The awardee party will be required to deposit an amount of **Rs. 10,000/- (Rupees Ten Thousand Only)** on account of security deposit by way of DD or pay order in favour of PAO, CPAO, New Delhi before entering into contract. This deposit shall be refunded after the satisfactory completion of the contract.
- 13 CPAO reserves the rights to reject any or all the quotations received without assigning any reason.
- 14 CPAO shall reserves the right to forfeit the amount of Security Deposit, whose decision shall be final and binding in case any of the clause or the agreement is breached by the Awardee firm.

Terms and conditions


- 1 The entire area occupied by CPAO office shall be placed under watch and ward.
- 2 The Guards shall be provided continuously round the clock.
- 3 Nothing extra shall be paid for duty on closed holidays i.e. Sunday, Saturday and other holidays including National Holidays i.e. the rates should be quoted accordingly.
- 4 The guards should be capable of understanding Hindi and English.
- 5 The contractor shall recruit/deploy/depute trained, qualified and experienced personnel as Security Guards.
- 6 Recovery at double the rate of per day wage per guard shall be effected from the Agency if a Guard fails to attend duty.
- 7 The Agency shall change the guard, if his performance / duty is found unsatisfactory or on account of misbehaviour etc.
- 8 The guards shall be on duty in proper uniform.
- 9 The Agency shall be fully responsible for any loss or damage to the office property that may may have occurred due to laxity or negligence of duty on the part of the security personnel.
- 10 The contract will be valid for a period of one year. However, CPAO may terminate the contract at any time without assigning any reason. .
