Sub: Pending revision of pre-2006 pension cases.

Though a substantial number of pre-2006 pension cases have been revised, still 5,648 pension cases are pending for revision constituting 1.30 percent of Civil Ministries/Departments. Out of this, 3760 cases (67%) pertain to 8 Ministries/Departments where the pendency is more than 200 cases, viz Home Affairs (1075), CBEC (751), Atomic Energy (518), PPG&P (381), Prasar Bharti (350), HRD (264), Telecommunication (217) and Finance (204). The details of unrevised cases are provided under the CCA & PAO login of CPAO website (www.cpao.nic.in).

You are requested to issue instructions to your PAOs to finalize all such cases and where details of pensioners are not available, the same may be obtained from the paying branches in the attached format (copy enclosed).
