**OFFICE MEMORANDUM**

**Sub: Revision of 1/3<sup>rd</sup> commuted portion of pension in respect of Government servants who had drawn lump sum payment on absorption in Central Public Sector Undertaking/Central Autonomous Bodies- representation/ clarification consequent to Implementation of Government's decision on the recommendation of the 6<sup>th</sup> CPC-regarding.**

The OM. No.4/38/2008-P&PW (D) dated-15.09.2008 followed by OM dated-27.05.2009 issued by Department of Pension & Pensioner Welfare was silent on the authority to issue revision authorities on 1/3<sup>rd</sup> commuted portion of pension in respect of Government servants who had drawn lump sum payment of pensioner on absorption in Central Autonomous Bodies.

2. As such the clarification from Deptt. of P&PW was sought for and they had clarified the position vide their note dated-23.06.2009 that the pension sanctioning authority will sanction the revision of pension as per 6<sup>th</sup> Pay Commission and necessary revised PPO/authority will be issued by the concerned Pay & Accounts Officer.

3. The contents of this note was circulated to all banks and the same was posted on CPAOs website <http://pensionersportal.gov.in>. But unfortunately the same could not be circulated to Ministries/Departments and Pr.CCA/CCA/CA. Therefore, the same is now being enclosed alongwith a Ministry-wise detailed list of 'P' Category- Prorata Pension including PSU absorbee retirees for necessary action.

All Pr. CCAs/CAs are requested to sent necessary revised PPO/Authority if not already done to CPAO for further necessary action at this end.

**Subject:-** Revision of 1/3<sup>rd</sup> commuted portion of pension in respect of Government servants who had drawn lumpsum payment on absorption in Central Public Sector Undertakings/Central Autonomous Bodies - representations/clarifications consequent to Implementation of Government's decision on the recommendations of the Sixth Central Pay Commission - regarding.

Reference is invited to the CPAO UO No. CPAO/Tech/6<sup>th</sup> CPC/absorbees/2008-09/67 dated 03.06.2009 for clarification as to whether the pension disbursing authority (viz. banks) may revise the pension of absorbees drawing 1/3<sup>rd</sup> restored pension. They have also requested for ready reckoner for use of such disbursing authorities. The instructions contained in the OM dated 15.9.2008 and 27.5.2009 do not authorize the pension disbursing authority (viz. banks) to revise the pension of such absorbees. This exercise is expected to be done by Pension Sanctioning Authority only and necessary revised PPO issued by them before disbursement of such revised pension.
