Sir,

I am directed to refer to Court order dated 23.10.2008 passed by the High Court of Uttarakhand at Nainital in WP No. 2144 of 2007 (M/S) filed by Shri Omkar Nath Shastri S/o Late Shri Briz Mohan Lal Shastri and to say that the operative part of the court order dated 23.10.2008 is reproduced below:-

"The writ petition is allowed. Impugned order dated 29.3.2007 passed by respondent no. 1 is quashed. The respondent no.1 by a writ of mandamus is directed to consider the claim of the petitioner for grant of pension under the provisions of Swatantrata Sainik Samman pension Scheme 1980 and pass an appropriate order sanctioning the pension to him expediously as far as possible. No order as to costs".

- An L.P.A. was filed against aforesaid order in the Hon'ble High Court of Uttarakhand at Nainital and same i.e. Special Appeal No. 55 of 2009 was dismissed on 25.11.2009 by the Divisional Bench Hon'ble High Court. Thereafter, an S.L.P. was filed with the approval of Ministry of Law against the aforesaid orders in the Hon'ble Supreme Court of India as Special Leave to Appeal(Civil) No. CC 16511/2010. The Hon'ble Supreme Court vide order dated 8.11.2010 has dismissed the S.L.P. and however, it is made clear that this will not be cited as a prescedent for any other case.
- 3. In compliance of the aforesaid court orders dated 23.10.2008, 25.11.2009 and 8.11.2010, his case has been examined based on the claim made in the application, documents submitted in support of claim including CPCs and recommendations of the State Government and sanction of the President is hereby conveyed for grant of Swatantrata Sainik Samman pension provisionally .@ Rs. 3000/-p.m. (Rupees Three thousand only)) with effect from date of receipt

All the above documents should be duly attested by the District Magistrate or any Subordinate Officer, not below the rank of a Tehsildar. The stamp should clearly indicate the rank/designation and Department/ Office of the Officer concerned. On receipt of these documents, necessary PPO will be issued by PAO, MHA and thereafter authorisation to make payment to the nominated bank will be issued by Central Pension Accounting Office of Ministry of Finance.
