Non Tax Receipts Portal



Non Tax Receipts Portal (NTRP)

What is NTRP?

The objective of the Non Tax Receipts Portal (NTRP) popularly known as the NTRP, is to provide a one-stop window to citizens/corporates/Institutions/ other users for making online deposits of Non-Tax receipts (NTR) due to the Government of India (GoI).


Earlier, Non-Tax revenue of most GOI Departments/ Ministries was getting routed through instruments such as bank draft/Cheque/Cash. While electronic payments have earlier been introduced for facilitating payment of tax revenue, NTR payments were in Manual Mode. The NTRP fills this vacuum, and provides an end to end solution for the complete value chain of Non-Tax receipts, including online user interface, payments at the Payment Gateway Aggregator, NEFT/RTGS with RBI and accounting of the receipts by the Government department/ministry.

NTRP uses the modality of Payment Gateway Aggregator (PGA). A depositor can therefore make online payment to the Government using either a Credit Card, Debit Card, UPI or through Net-Banking of any of the banks integrated with the PGA. At present, seven PGAs are the Payment Gateway Aggregator for NTRP facilitating 150+ Net-banking options. NTRP is also integrated with the accredited banks of the different ministries. Funds deposited through these banks would be credited into the accounts of the respective departments/ministries.

NTRP Statistics

NTRP facilitates collection of online non tax receipts for all GoI department/ministries. It has the capability to collect small and large payments due to GoI (for example a low end receipt of Rs. 10 payment for an RTI application, while some of the high value payments would be dividend from Public Sector Undertakings and license receipts from telecom operators. Such large amounts can be of thousand of crores of rupees).

Annually, over Rs. 2,40,000 Crores are collected by different departments/ministries of GoI on account of non-tax revenue. The sector wise collection of these receipts in 2018-19 is presented in the following bar chart. The biggest bar of NTR flows from Dividends paid by the Public Sector Undertakings. The next biggest share comes from interest payments. Ministry of Telecommunication, falling under the category of economic services, is the single largest non tax revenue generating ministry.



Strengths of NTRP

NTRP is a direct feeder to Hon'ble PM's Digital India initiative

The biggest strength of NTRP is enhanced user convenience. Today a user has to make trips to the banks and sale outlets for using low value GoI services thus costing him time and effort. NTRP enables the citizen to pay for GoI services from within the confines of his home/office

Faster remittance to Government Account. The integrated seamless model of user interface to PGA to accredited bank means that the time cycle of flow of funds into GoI CFI is substantially shorter than the manual mode

NTRP would almost completely eliminate the probability of missing receipts, which is much higher in manual mode

Complete and Correct accounting: With NTRP, the accounting errors in case of NTR would be substantially minimised

NTRP offers an enhanced and effective MIS for NTR, which will allow the program managers to conduct a deeper monitoring and analysis of their receipts.
