Dear Shri

Please refer to Ministry of Personnel, Public Grievances & Pensions, Deptt. of Personnel & Training O. M. Nos. 25014/2/2002-AIS (II) dated 11.04.2007 and dated 20.12.2007 whereby the pension liability of the AIS officers was taken over by the Central Government under the scheme with effect from 01.04.2008. Accordingly, CPAO the nodal organization for authorization of pension had written a letter No. CPAO/Tech/AIS/2007-08/888-916 dated 05.12.2007 (copy enclosed) to your State asking for the detailed information so that the necessary budget could be provided. We had also sought for the appointment of a Designated Authority (DA) who would be the Nodal Officer to process and submit the pension cases to this office as well as for the creation of a data base of all the retired as well as retiring All India Service officers well in time. The Designated Authority was also required for details on provisioning of funds for the said scheme through CPAO. Though the scheme has started from 01.04.2008, we do not have any information regarding the number of pensioners who would be interested in the scheme nor any details of appointment of Designated Authority including their attested signature of authorized signatory. Formulation of budget is also hampered.

For speeding up the implementation of the scheme, it has been decided to have a workshop on 20th of January, 2009 at 11:00 AM in the Conference Room of the Central Pension Accounting Office situated at Trikot-II Building, Bhikaji Cama Place, New Delhi - 110 066. You are requested to depute a nodal person to attend the same.

Subject:- Simplification of Procedure for payment of pension and other Benefits to All India Service Officers retiring from Government of India/ State Government.

Sir,

I am directed to refer to Ministry of Personnel, Public Grievances and Pensions, DOPT's letter No. 25014/2/2002-AIS (II) dt. 11th April '07 on the subject cited above and addressed to Chief Secretaries of All States and copies endorsed to all AGs and Ministries/ Departments of the Government of India.

In this connection it is informed that CPAO has been functioning as a central and nodal organization in authorizing pension payments through banks, monitoring the reimbursement and budgeting for retirement benefits to all Central Civil Pensioners. At the time of its inception in the year 1990 (01.01.1990) there were about two lakh pensioners and till date the number of pensioners for Central Civil has crossed 7.25 lakhs.

This new scheme entails taking various advance steps such as nomination of Designated Authorities who will process and submit the pension cases to this office, creation of primary data base of all the retired as well as retiring AIS-Pensioners at this end, budget estimates and provision of funds thereof, allotment of new PPO code nos. (Computer code Nos) etc.

Exact date of taking over pension liability has been proposed as 01.04.2008 to the Government, by the CPAO.

It is, therefore, requested to furnish the requisite information as per details given in the proforma attached. The consolidated data may also be furnished in CD. Since we have to make budget provisions, it is requested that the information may please be sent to us through the Designated Authority urgently. For any further clarification, we may be contacted immediately.

This may please be treated as Most urgent. Further communication will follow.
